

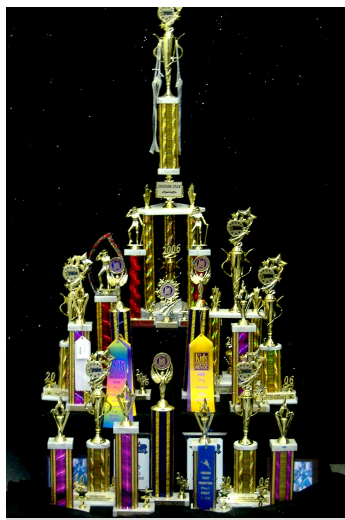

RULES, REGULATIONS AND COMPETITION CONTRACT

YOU HAVE BEEN SELECTED

to participate as a Competition Team Member at JCA Dance Academy.

The following rules and regulations must be reviewed and this contract must be signed and returned by August 9th, 2006.

Fees are also due by August 9th, 2006.

- ★ Registration Fee - Nonrefundable fee in the amount of \$35 per family. If paid before June 30th, fee is \$25.
- ★ Performance Fee - A fee of \$20 per dancer will be collected to help cover the expense of props, extra costume accessories, extended music time fees, etc.
- ★ Costume Deposit - A fee of \$50 per dancer for each performance will be collected so we may place the costume orders early. Remaining balances will be due in October/November.
- ★ Tuition - Tuition for August and September lessons will be due on the first night of dancing. August will be a pro-rated month since dancing will begin on the second week. Thereafter, each month of dancing will be paid in advance of the upcoming month on the first day of dancing. Example, October payment will be collected on the first night of dancing in September.

RULES & REGULATIONS

- ★ Attendance - Regular attendance is mandatory for all classes. Excessive absenteeism will result in your child being delegated an "alternate" position until the instructor feels the dancer is on track with the material missed or may result in immediate dismissal from the team.
- ★ Rehearsals - Competition dates may require our teams to participate in special rehearsals. These are held to finalize all the details necessary for a competition performance. Fees will be imposed for these rehearsals and all dancers are required to be in attendance.
- ★ Travel - All dancers traveling to competitions are invited to stay at the same hotel and will be provided maps and all details regarding accommodations.
- ★ Award Ceremonies - All dancers are required to be on stage in the appropriate JCA warm-ups or tee shirts approved by the studio. Instructors will appoint individuals responsible for accepting the awards.

No gum, purses, MP3 players, cell phones, food or drinks are permitted on stage.

It is understood, all team members are to attend all competitions scheduled. JCA Dance Academy has the right to schedule an out-of-town National appearance if our teams qualify for such an event.

All dance parents and dancers are to behave in a manner that is complimentary to all. It is important that all our groups support each other as we are a reflection of one another.

This contract is to be signed and dated by both the dancer and the parent responsible for payment of all fees.

I have received the rules and regulations set forth by JCA Dance Academy regarding my participation on a competition team. I understand my responsibility of being a team member and agree to comply with all the rules and regulations as stated. I also understand failure to do so may result in my being dismissed from the team. I understand, upon my dismissal from the team or the studio, any fees paid are non-refundable and any outstanding fees are to be paid in full or will be purposed through the courts by ownership of JCA Dance Academy to settle any or all debts. I also agree to refrain from use of performance material and costumes for one year after my dismissal.

JCA Dance Academy reserves the right to purchase my costumes if necessary to fill my position and will give fair market value for same.

JCA Dance Academy also reserves the right to serve legal notice on any individual defaming the studio, its owner, instructors or anyone affiliated with same. Use of "JCA Dance Academy" is reserved and must be approved by Jo McGill.
